1 To the Honorable members of the Burnett County Board of Supervisors;



3 **WHEREAS**, Burnett County administers Wisconsin Administrative Code, Chapter NR 135
4 under the authority of the Burnett County Non-Metallic Mining Ordinance; and

6 **WHEREAS**, Section 27.30 of the Burnett County Non-Metallic Mining Ordinance and
7 Wisconsin Administrative Code Chapter NR135.39(4)(b) require that “fees must equal as
8 closely as possible the County or Municipality’s expenses to administer the program”; and



10 **WHEREAS**, the costs of administering the program have exceeded the revenues brought in
11 by the current fee schedule;

13 **NOW, THEREFORE BE IT RESOLVED, THAT** Addendum I of the Burnett County
14 Non-Metallic Mining Ordinance be amended to create a new fee schedule for annual fees and
15 plan review fees to recover the actual costs of administering the program.



1-5 Acres	\$215.00 (\$180.00 County, \$35.00 DNR)
6-10 Acres	\$400.00 (\$330.00 County, \$70.00 DNR)
11-15 Acres	\$585.00 (\$480.00 County, \$105.00 DNR)
16-25 Acres	\$770.00 (\$630.00 County, \$140.00 DNR)
26-50 Acres	\$890.00 (\$730.00 County, \$160.00 DNR)
51+ Acres	\$955.00 (\$780.00 County, \$175.00 DNR)
Inactive	\$115.00 (\$100.00 County, \$15.00 DNR)

Plan Review Fees

\$120.00 - less than 4 hours

\$30/hour - more than 4 hours

\$120.00 plus \$30/hour - Expedited Plan Review
