





1 To the Honorable members of the Burnett County Board of Supervisors;

3 **WHEREAS**, according to Wis. Stats. 83.01(2) the county highway commissioner shall serve for
4 a term of two years unless the county board establishes a different term of service by ordinance;

7 **WHEREAS**, the job responsibilities of the county highway commissioner necessitates long
8 range planning and long range goals; and

10 **WHEREAS**, Resolution 2002-21 adopted December 19, 2002, approved the appointment of
11 Robert Morehouse as the county highway commissioner for an indefinite term; and

13 **WHEREAS**, the county code of ordinances must be updated to reflect the term of service of the
14 county highway commissioner position to an indefinite term of service.

16 **NOW, THEREFORE BE IT RESOLVED, THAT** the Burnett County Board of Supervisors
17 approves the term of service of the county highway commissioner position to an indefinite term
18 of service and approves the attached update to the Burnett County Code of Ordinances.
